### MENTORING EXPERIENCE

During 19 years at MSU, I have worked with more than two dozen graduate students, guiding them on tasks ranging from data cleaning and codebook preparation to producing their own analyses and preparing blog posts and press releases. Almost all of these Research Assistants now have at least one Afrobarometer publication to their credit, and many of them have multiple publications. One of them has gone on to become a member of the Afrobarometer senior leadership team. In addition, I have mentored numerous Afrobarometer junior staff who have been interested in doing analysis and getting publications. The successful efforts of Afrobarometer (myself and other senior colleagues) to mentor our partners and junior staff as they play a growing role in producing Afrobarometer analysis and publications are reflected in our publication numbers, and the author profiles: almost all Afrobarometer Dispatches and Policy Papers are now authored or co-authored by African staff and partners in the network, and this is true of an increasing number of Afrobarometer Working Papers as well.
